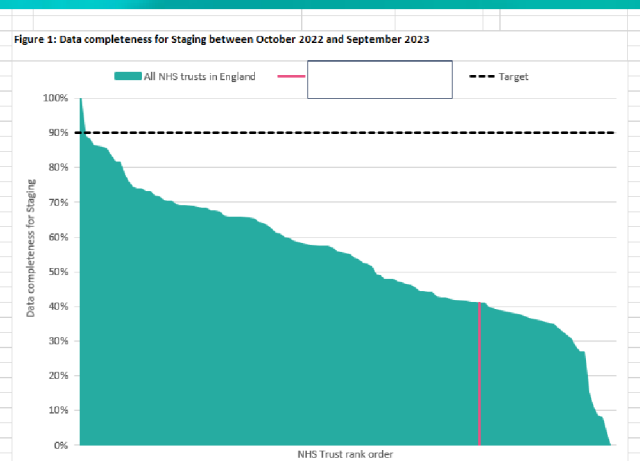

### Reporting Update

In April, the National Ovarian Cancer Audit published its first **quarterly data dashboard** on the NOCA website [here](#). The first two quarterly dashboards (April and July 2024) report on data quality and completeness only with subsequent quarterly reports from October 2024 including performance indicators. These reports will allow trusts to monitor their performance on an ongoing basis with new data each quarter. Our first **State of the Nation report** will publish in September 2024 including national recommendations. Look out for more details in the next newsletter!



### NOCA PPI Forum

We held our first Patient and Public Involvement (PPI) Forum meeting on 19th April. A big **thank you** to Ovarian Cancer Action and Target Ovarian Cancer for their help with recruiting members to the forum, and to those patients who attended the meeting. The patient voice is central to the National Ovarian Cancer Audit and the members of the forum will provide valuable insight into our work.



### NOCA/BGCS webinar

The National Ovarian Cancer Audit hosted a webinar together with the British Gynaecological Cancer Society (BGCS) on 18th April to provide some initial findings on the data we have received on NHS trusts in England. NOCA uses the nationally mandated flows of data from hospitals to the National Disease Registration Service (NDRS) in NHS England. We hope everyone who listened to the webinar found it useful. **We would love to hear your feedback about future topics for webinars and quality improvement events.**

### Healthcare Improvement Plan

We will be publishing our Healthcare Improvement Plan on the NOCA website in the coming weeks. This document outlines our five Quality Improvement goals and seven performance indicators, along with further information on our quality improvement strategy, including the healthcare improvement framework and improvement activities. The document was developed with input from the NOCA Clinical Reference Group and builds on the [NOCA scoping document](#) which was published at the end of 2023.
