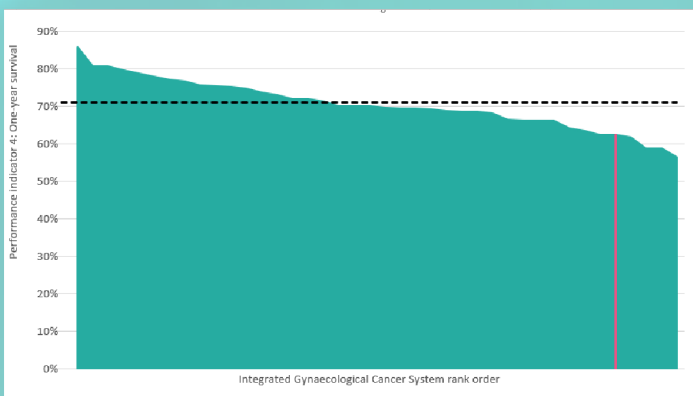

### January Quarterly Report - interactive data dashboard



The next **NOCA quarterly report** will be published on the [NATCAN website](#) on **9th January 2025**, subject to clearance and sign-off. This report includes more recent data, patients in England diagnosed up to June 2023. For the first time, the report will be an interactive data dashboard, allowing trusts to view provider-level results online. This version also includes an additional performance indicator on two-year survival. With new data each quarter, these reports will allow NHS providers to track their progress and monitor local quality improvement. These dashboards are subject to ongoing iterative development, and we therefore welcome suggestions and feedback, which can help guide changes made in future releases.

### NOCA/BGCS webinar

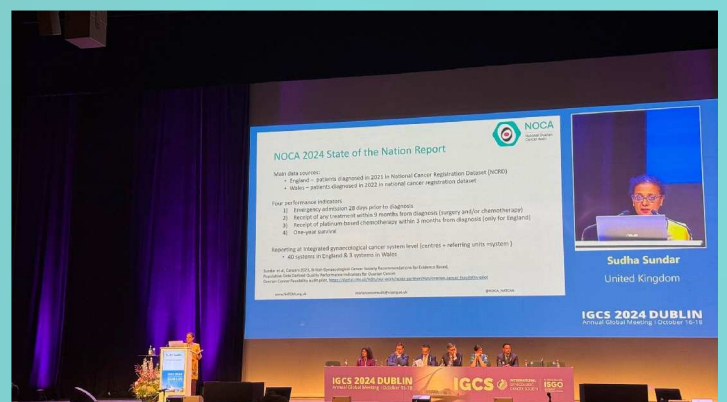
