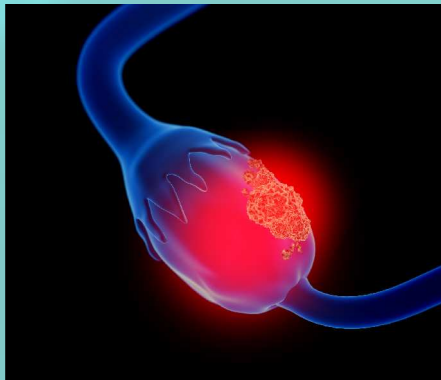

### State of the Nation Report 2025 – published on the new NATCAN website!



NOCA has published its 2nd **State of the Nation Report!** You can find it on the new and improved [NATCAN website](#) along with supplementary materials including a [methodology supplement](#), [State of the Nation data dashboard](#) and a [patient and public version of the report](#). The report includes women diagnosed with ovarian cancer in England in 2022 and Wales in 2023. This year the report includes data on two-year survival as well as a new performance indicator: 'Any treatment (surgery and/or chemotherapy) within 3 months for all women diagnosed with ovarian cancer who had an emergency hospital admission in the 28 days prior to diagnosis'. The report includes five recommendations to drive improvements in the quality of ovarian cancer care.

### October quarterly report – interactive data dashboard

The next [NOCA quarterly data dashboard](#) will be published on the NATCAN website on 9th October 2025, subject to clearance and sign-off. This report includes more recent data, as well as our new performance indicator: 'Any treatment (surgery and/or chemotherapy) within 3 months for all women diagnosed with ovarian cancer who had an emergency hospital admission in the 28 days prior to diagnosis'. ### UKGOM 2025

### QI intervention and GOT You study

NOCA will launch its Quality Improvement (QI) intervention in October 2025. Focussed on the following performance indicator 'Percentage of women diagnosed with ovarian cancer within 28 days after an emergency admission who receive any treatment (surgery and/or chemotherapy) within 3 months from diagnosis', we will be contacting the clinical leads at all Gynaecological Cancer Systems in England and Wales to discuss their results and encourage them to identify ways to improve their performance. Alongside the QI intervention, NOCA plans to launch the GOT You study, initially collaborating with select Gynaecological Cancer Systems. This collaboration will involve system diagnosis which will enable the participating sites to identify barriers and opportunities for improvement. NOCA's long term goal is to expand the GOT You study into a national QI intervention.
