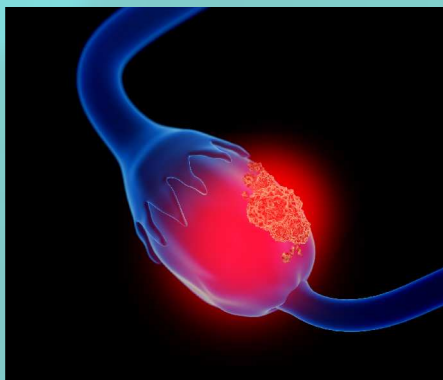

State of the Nation Report 2025



NOCA will be publishing its 2nd State of the Nation Report on **11th September 2025**, subject to clearance and sign-off. This report will include women diagnosed with ovarian cancer in England in 2022 and Wales in 2023. This year we will include data on two-year survival as well as a new performance indicator: 'Any treatment (surgery and/or chemotherapy) within 3 months for all women diagnosed with ovarian cancer who had an emergency hospital admission in the 28 days prior to diagnosis'. The report will include five recommendations to drive improvements in the quality of ovarian cancer care. NOCA will also publish a patient and public version of the report on the same date.

July quarterly report - interactive data dashboard

The next NOCA quarterly data dashboard will be published on the NATCAN website on **10th July 2025**, subject to clearance and sign-off. This report includes more recent data, patients in England diagnosed up to December 2023. This report is in the format of an interactive data dashboard, allowing trusts to view provider-level results online. In addition, trusts are now able to download trust-level reports to see all performance indicator results for their trust. This quarter we will be including a new data quality metric on residual disease (disease that's left behind after surgery).
